What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: •Social Security number and checking account information. •Payment history and income. •Employment information and wire transfer instructions.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reason Riverbend Finance, LLC chooses to share; and whether you can limit this sharing.

Who we are:**Who is providing this notice?**

Riverbend Finance, LLC a business entity of the Fort Belknap Indian Community, is providing this privacy policy.

What we do:**How does Riverbend Finance, LLC protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures. These measures include computer safeguards and secured files and buildings.

How does Riverbend Finance, LLC collect my personal information?

We collect your personal information, for example, when you:

- Apply for a loan;
- Give us your income information;
- Tell us where to send the money;
- Provide account information;
- Provide employment information; and
- We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

Why can't I limit all sharing?

You have the right to limit only:

- Sharing for affiliates' everyday business purposes information about your creditworthiness;
- Affiliates from using your information to market to you; and
- Sharing for nonaffiliates to market to you.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions:**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include other business entities of the Fort Belknap Indian Community.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Riverbend Finance, LLC does not share with nonaffiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Riverbend Finance, LLC does not jointly market.*
